

Announcement of the Sirindhorn International Thai-German Graduate School of Engineering on Type of Publications as Graduation Requirement for Doctoral Degree

According to the resolution of the committee meeting of the Sirindhorn International Thai-German Graduate School of Engineering No. 10/2023 on October 4, 2023, the resolutions of the King Mongkut's University of Technology North Bangkok Council in meeting No. 12/2566 on December 20, 2023, and in meeting No. 5/2567 on May 29, 2024, approved the type of publications as the graduation requirement for the doctoral degree at the Sirindhorn International Thai-German Graduate School of Engineering as follows:

All graduate students in the doctoral study program must partially publish their thesis/dissertation work in at least two international journals with a full article according to the following conditions:

- (1) Two Research Articles or
- (2) One Research Article and One Review Article or
- (3) One Research Article and One Short Research Article which can be in various names such as Letter, Short Communications/ Communications and Technical Notes/ Technical Briefs

In the case of publishing a Review Article for graduation of doctoral degree students, one review article can be submitted together with one research article. The review article must be part of the thesis work. It must be published in an international journal listed in the SCOPUS database at the Q1 or Q2 level only. The student must contribute 50% or more to this review article. Students must be the first author in the review article with the advisor being a co-author or corresponding author.

In the case of publishing a Short Research Article which can be in various names such as Letter, Short Communications/ Communications and Technical Notes/ Technical Briefs, the short research article must have the following characteristics:

(a) It is a report of results that are important and valuable to research and engineering work. But the scope and information content are shorter than a full research paper. The work may consist of

1) Preliminary reports on results that have not yet been fully developed or interpreted; and

2) The report contains technical points that may be of interest to readers.

(b) It is a summary report of the research work. This information is, of interest to many researchers and could stimulate further research in this field or communicate information in highly competitive or rapidly changing subject areas before researchers publish the full research article.

(c) It must be a work with content in English, at least 2 A4 pages, or at least 2,000 words, and the work must not include only abstracts. Such published work must be considered by the peer review committee of the journal or publication.

(d) It must be published in an international journal listed in the Web of Science (WoS) or SCOPUS database at the Q1 or Q2 level only.

(e) The student must contribute 50% or more to this review article. The student must be the first author in the short research article with the advisor being a co-author or corresponding author. In the case that the student cannot be the first author, the contribution in percentage or ratio must be declared and signed by the advisor prior submitted for the graduation.

This announcement shall be effective from the first semester of the academic year 2023 onwards.
