Both parties agree to enter the 'Agreement' as follows.

1. 'TGGGS Advisor' and 'TGGGS Student' agree to collaborate on the thesis research work in the topic of which is a copyright of King Mongkut's University of Technology North Bangkok.

2. 'TGGGS Student' agrees to maintain any information concerning the thesis research work in confidence. 'TGGGS Student'must not disclose to public or third party(s) the information wholly or partly for commercial or any other purposes. In addition, 'TGGGS Student'must not use the information which could cause damage to 'TGGGS Advisor' and the university. If 'TGGGS Student' would like to ask 'TGGGS Advisor' for the technology transfer (or the license/ the assignment, attending an exhibition/conference displaying the thesis work) on this thesis, a written agreement will be made afterwards.

3. When either party breaches any provision hereof, he or she accords to pay extensive damages which occurs or will occur in the future to the other party and the other party is entitled to get the case to court.

4. When either party breaches any provision hereof, he or she accords to pay extensive damages which occurs or will occur in the future to the other party and the other party is entitled to get the case to court.

This 'Agreement' is non-binding and will remain in force for a period of ten (10) years from the effective date of this 'Agreement'. Any amendment and/or modification of this 'Agreement' shall require written approval from the authorized representatives of all parties.

This 'Agreement' is made in two copies which have the same and accurate contents. In Witness Whereof, the parties have already read and understood all the contents of the Agreement, and have signed their names in the presence of witnesses.
